

**Chashah Monastery Parliament**  
**Spiritual Laws of Service (SLS)**

This document aims to provide an understanding of the terms and conditions for individuals aspiring to be Volunteers at Chashah Monastery Parliament (CMP). It emphasizes the utmost importance of maintaining the integrity of the Spiritual Laws of Service (SLS) and sheds light on additional practices and commitments associated with volunteering.

**1. Background:**

Chashah Monastery Parliament serves as an Ethereal institution devoted to spiritual growth and community service. By becoming a Volunteer, you will have the opportunity to contribute to the noble mission of the monastery to play a vital role in a harmonious and compassionate environment.

**\*Note: You do NOT have to be Chashah to volunteer, but you MUST be of Horn African descent in order to work for and or volunteer for Chashah Monastery.**

**By checking the below responsibilities, you agree to the terms and conditions outlined in this document, and will demonstrate your commitment to Chashah Monastery Parliament and its noble mission.**

**2. Volunteer Responsibilities:**

- 2.1. Daily Prayer to ƦƦƦƦ:** As a Volunteer, you are encouraged to engage in daily prayer to ƦƦƦƦ, but it is not required.
- 2.2 Acknowledgement:** Acknowledge ƦƦƦƦ before working on any Chashah Monastery project by simply saying, **“ƦƦƦƦ, please help me to accomplish your will for this project.”**
- 2.3. Use of ƦƦƦƦ's Name:** To maintain the sanctity of our faith, volunteers are instructed to exclusively use the name of ƦƦƦƦ when representing Chashah Monastery Parliament and refrain from using other titles such as "god," "lord," or "jesus" while conducting Chashah Monastery Parliament business. Volunteers are NOT forced to Volunteer for the Chashah Monastery, but upon doing so, Volunteers MUST adhere to all rules, just as any job requires.
- 2.4. Worship on the SANBAT (SANBAT - Calculated monthly):** Volunteers are not required to participate in worship on the SANBAT (day of Spiritual Rest), known as SANBAT. During SANBAT, Volunteers **DO NOT** conduct CMP business because it's against CMP ethereal policies. What Volunteers do outside of CMP during SANBAT is not our concern on SANBAT.
- 2.5. Annual Feast Day Celebrations:** Chashah Monastery Parliament celebrates nine (9) annual Feast days throughout the year, ranging from March to October. Feast Day celebrations will be announced in advance. As a Volunteer, you are not required to participate in these celebrations. All Volunteers shall **NOT** conduct any CMP work on these special occasions because it's against CMP ethereal policies.
- 2.6. Adherence to Chu'kai (Bible) Laws and Commandments:** Volunteers are required to follow the laws and commandments outlined in the Qeddase SANBAT chronicles, specifically in Leviticus and Exodus. By upholding these teachings, you contribute to the preservation of our spiritual integrity.

**3. Termination of Volunteer Status:**

If a Volunteer fails to comply with the terms and conditions outlined in this document or engages in activities that are detrimental to the monastery's reputation, their volunteer status will be terminated.

Your role as a Volunteer will not only support the monastery but also provide you with an opportunity for personal growth and spiritual development.
